#### **2006 Progress**

Continued to work with the Information Providers to deliver solutions which eliminate estimate rekeying between the same brand of estimating system (X-to-X)

In San Jose, held a panel presentation where each Information Provider gave an update on their development status

To date, all three Information Providers have released solutions that address <u>at</u> <u>least a portion</u> of the issue

#### What's next?

EC Committee will gather feedback and utilization statistics early next year and present them at the summer CIC meeting. We want to determine:

- > How many estimates have been downloaded so the shop doesn't need to rekey the estimate?
- > How many shops are using the solutions?
- > Which insurers are not participating in the download solution and why?

> Do the solutions solve the rekeying problem?



#### What's next? (cont.)

 Start working to define issues and potential solutions related to the elimination of supplement rekeying

Supplement rekeying is more complicated to solve than estimate rekeying because:

- > There are a variety of business processes used by insurers
- > Information providers have different capabilities

> The supplement process differs based on the insurer / shop relationship
