The goal of this survey is to get your comments and feedback as input to the 2006 CIC Planning Meeting. We'd like specific input on the issues or problems you'd like the EC Committee to address next year. We have outlined 5 potential projects below which are continuations of this year's initiative to eliminate Estimate Re-keying between the **same** brand of estimating system (aka, X-to-X). If the EC Committee were to continue to address Estimate Re-keying issues, **what problem is the most important one to solve?** Please Rate the following solutions with HIGH, MEDIUM or LOW priority. Note that "X-to-X" is between the SAME brand of estimating system and "X-to-Y" is between DIFFERENT brands of estimating system.

Priority = High, Medium or Low		Priority
1.	Stay the Course: <i>Finish working on the elimination of re-keying between X-to-X and then stop. That takes care of the bulk of the re-keying problem.</i>	
2.	X-to-X Supplement Communication Process: <i>Allow electronic communication of supplements from a non-DRP estimate or from a transferred Estimate.</i>	
3.	X-to-Y without P-Page Logic: <i>Transfer all Administrative and Estimate Line Data from X-to-Y with all estimate lines flagged as a manual entry.</i>	
4.	X-to-Y with Administrative Info only: <i>Transfer all Administrative Data from X-to-Y, but don't transfer the Estimate Line data.</i>	
5.	X-to-Y with P-Page Logic: <i>Transfer all Administrative and Estimate Line Data from X-to-Y and enable P-Page Logic.</i>
